Description

The Metropolitan Smooth Growth Fund (Lesotho) invests in local, RSA and global investments in line with a strategy designed to suit the objectives of the product. Underlying returns are smoothed to reduce the volatility otherwise associated with investing in markets.

Fund Objective

The Fund targets a smoothed return of CPI + 4% per annum, net of all underlying asset charges but gross of investment management fees, over a five-year time horizon

Bonus Declaration Method

With effect from 1 June 2007, vesting and non-vesting final bonuses are declared monthly in advance.


(b) Underlying Asset Charges

1% Capital charge per annum.


In addition to the Capital charge, Pooled Portfolio fees are payable in respect of the foreign assets.
